TERMS and CONDITIONS

AGM association of Cervignano del Friuli organizes an international advance singing Masterclass for Opera Singers. The course will be led by prof. Sherman Lowe, one of the most sought-after teachers of opera singing.

Lessons and locations: The course includes four individual lessons with the teacher and a piano accompanist, and four additional lessons with piano accompanists.

Location: The course will be located in the establishments of AGM Association and Centro Civico in Cervignano del Friuli (Italy). The final concert will be in Teatro Pasolini, main Theater of the city.

Admission: Only 5 students will be accepted at the course.

Students who have a singing diploma or bachelor's singing degree, have priority over the others candidates for the admission to the course. A video is required to complete the admission.

Auditor students are allowed to the course.

Documents required for the registration:

1. Registration form filled in and signed (download is available from the web page: www.agmaccademia.com)
2. A brief Curriculum Vitae
3. A copy of identity card or passport document
4. A short video to show the skills of the student
5. A list of arias will be studied at the course (at least one of them has to be written by W. A. Mozart)

The association going to send the selection results by e-mail; then the selected singers can complete the registration.

Payments: The entry fee is 45,00 € and include AGM membership card (both for auditors and singers). For the members of AGM the entry fee is 20,00€. The inscription fee is not refundable in case of withdrawal.

The attendance fee for the selected singers is 505,00€

Deadlines: The deadline to send the registration form and the payment for entry fee is 15/01/2020.

The deadline for the selected singers to make the payment of the course is 20/01/2020.

Attendance: The attendance at lessons is mandatory.

Conventions and benefits: AGM association will send information on benefits and accommodation and meals agreements, by e-mail. More information will set on the web page.

Final Concert: All selected singers will perform in the final concert, but the association specify there will no payments or reimbursed for the performances.

At the end of the final concert the student will receive a certificate of the attendance at the course.

Other activities and concerts: The students who attended the course could be selected for other future concerts organized by the association.

Students and auditors: A certificate of attendance will be provided also for auditors who will follow at least the 80% of the lessons of the course. Auditors have the possibility to interact discreetly with the teacher during the lessons.

Cancellations: The organization have the right to cancel the course if the smallest number of participants is not reached. In case of cancellation all the payments will refund.

Audio/video recordings: With the registration, students and auditors give to the association the right to take pictures or make audio and video recordings during the final concert.

In particular, the participants assigns all rights of pictures, sound and video recordings to the association. The organization reserves the right to use images and recordings to promote the present course or future events.
